1.Offer Terms and Conditions

- 1.1 These terms and conditions supplement Bord Gáis Ireland's standard terms of service, accessible via the Fixed Term Standard Meter Terms and Conditions and the Fixed Term Smart Meter Terms and Conditions. The standard terms outline key obligations, responsibilities, service activation procedures, and general contractual provisions. By accepting this offer and engaging with Bord Gáis Ireland, you agree to be bound by both these supplementary terms and the standard service terms.
- **1.2** Participation in this promotion constitutes your agreement to comply with all relevant terms, including any updates or amendments made by Bord Gáis Ireland from time to time. It is your responsibility to review the full standard terms regularly to understand your rights and obligations under the contract.
- **1.3** Throughout the entire registration and sign-up process, a recorded call will serve as your electronic signature. By participating in this process, you acknowledge and agree that the recorded call will serve as your contractual acceptance. It is your responsibility to provide accurate and truthful information during this process, as the information supplied will form the basis of your agreement with Bord Gáis Ireland.

2. Discounted Rates for IFA Members

- **2.1** As a member of the Irish Farmers' Association (IFA), you are eligible to access discounted electricity rates for qualifying properties. Eligibility is subject to meeting the criteria outlined in the Bord Gáis Ireland contract and the specific plan or promotion you select. It is your responsibility to ensure that your property satisfies these conditions and qualifies for the discount.
- **2.2** The specific discounted rates and any associated cashback offers, such as the IFA Cashback, are exclusively available to eligible members under this promotion. These discounts cannot be combined with other discounts, promotions, or special offers unless explicitly authorized by Bord Gáis Ireland.
- **2.3** The IFA Member Services initiate the signup process by submitting your details to Bord Gáis. Beyond this initial step, the completion of your order, activation of services, and any support requests or additional information must be handled directly with Bord Gáis Customer Support to ensure effective management of your account and services.

3. Contract Duration and Termination

- **3.1** Accepting this offer commits you to a contractual agreement with Bord Gáis Ireland. The minimum contractual period will depend on the specific plan or promotion you choose, which will be confirmed at the time of activation. Typically, the minimum duration is detailed in the plan description.
- **3.2** If you terminate the service before the minimum period expires and an Early Termination Fee (ETF) applies, you will remain responsible for paying any outstanding ETFs or penalties associated with early termination, regardless of the discounted rates applied during your contract. The discounted rates do not exempt you from your contractual obligations or fees.
- **3.3** Bord Gáis Ireland reserves the right to amend, suspend, or withdraw the promotion at any time without prior notice. If such action occurs, your continued participation depends on your compliance with the latest terms and conditions.
- **3.4** To maintain eligibility for the discount, your IFA membership must remain active throughout the contractual period. If your membership expires, is cancelled, or becomes invalid for any reason, Bord Gáis Ireland reserves the right to revoke the discount and revert your account to the standard tariff for the remainder of your contract.

4. Communication and Data Consent

- **4.1** By accepting this offer, you agree to receive communications related to the promotion, your services, and other updates from Bord Gáis Ireland or the Irish Farmers' Association. These may be sent via post, telephone, email, or text message.
- **4.2** You are responsible for ensuring that all information provided during the sign-up process, including details given during the recorded call, is accurate and complete. - **4.3** You have the right to opt out of receiving these communications at any time by contacting Bord Gáis Customer Services to request removal from promotional or service-related mailing lists.
- **4.4** Bord Gáis Ireland may request proof of your current IFA membership at any time during the contractual period. If verified that you are no longer an active IFA member, the discount may be discontinued, and your account will automatically revert to the standard tariff for the remaining contract period.
